# CBJT Scholarship Agreement

**As a CBJT scholarship award recipient I understand and agree to the following:**

- In order to keep receiving the CBJT scholarship, I must stay in good academic standing. If my G.P.A. drops below a 2.0, I must meet with the Project Director. I will have one term to satisfactorily raise my G.P.A. Failure to do so may result in the loss of my scholarship.
- If I switch to a major or program format not funded by the grant, I understand that I will lose my scholarship.
- I understand that I must reapply for the scholarship yearly. Receiving the scholarship one year, does not guarantee that I will be selected to receive a scholarship the second year.
- I understand that providing false information on my CBJT Participant Application can disqualify me from receiving my awarded scholarship.
- I agree to file the FAFSA form yearly. If I am awarded a federal or state grant, I understand that this money will be applied to my bill, before the scholarship money. This includes the PELL grant. Failure to file the FAFSA may result in the loss of my scholarship.
- I understand that the CBJT scholarship can only be used for tuition, books, and fees. Under no circumstances will a difference check be issued from CBJT funds.
- If I am enrolled in Supply Chain Management, I understand the scholarship will pay for one diploma in a single concentration area. I must reapply if I want to be considered for funding in additional concentrations.
- If I am not a Florida resident, I understand that the scholarship will only fund the portion of my bill equivalent to in-state-tuition. I will be responsible for the remaining amount.
- I understand that the Department of Labor and Florida Gateway College are making a significant investment in me by providing me with this scholarship. I agree to take my responsibilities as a student seriously. These responsibilities include having good attendance, turning in assignments on time, and seeking help when I need it. I will treat myself and others with respect during my time at Florida Gateway College.
